- **Broiler-** Number of Birds per flock ÷ 1000 X Avg. wt. X Number of Flocks X .25 (for birds less than 4lbs multiply by .225)
  - **Example:** 100,000 birds with an avg. weight of 4lbs raising 5 flocks per year  
 $100,000 / 1000 \times 4 \times 5 \times .25 = 500 \text{ tons of litter.}$
- **Pullet-** Number of Birds per flock ÷ 1000 X number of days in production X Avg. Wt. X .011 X number of flocks ÷ 2
  - **Example:** 60,000 birds for 21 days in production with an avg. weight of 2lbs raising 4 flocks per year  
 $60,000 / 1000 \times 21 \times 2 \times .011 \times 4 / 2 = 55.44 \text{ tons of litter}$
- **Breeder Hen-** Number of Birds per flock ÷ 1000 X number of days in production X Avg. Wt. X .015 ÷ 2
- **Turkey** – Number of Birds per flock X number of flocks X number of days in production X Avg. Wt. X 0.012 ÷ 2000
